NOTIFICATION

Whereas the draft of the following rules further to amend the Karnataka Factories Rules, 1969 was published, as required under Section 115 of the Factories Act, 1948 (Central Act, 63 of 1948), in exercise of the powers conferred by section 112 of the said Act, vide Notification No.LD 14 LET 2010, dated:22.06.2010 in Part IV-A of the Karnataka Extraordinary Gazette dated:22.06.2010 inviting objections and suggestions from all persons likely to be affected, thereby, within 45 days from the date of publication in the official gazette.

And whereas the said gazette was made available to the public on 22.06.2010.

And whereas no objections and suggestions have been received in respect of the said draft by the State Government.

Now, therefore, in exercise of the powers conferred by Section 112 of the Factories Act, 1948 (Central Act, 63 of 1948), the Government of Karnataka hereby makes the following rules, namely:-

**RULES**

**1. Title and Commencement:**

- (1) These Rules may be called The Karnataka Factories (Amendment) Rules, 2010.
- (2) They shall come into force with effect from 01.01.2011

**2. Amendment of Rule 3:** In the Karnataka Factories Rules, 1969 (hereinafter referred to as the said rules), in sub-rule (2), for the words and figure “rupees two hundred and fifty”, the words and figure “rupees five hundred”, for the words and figure “rupees five hundred”, the words and figures “rupees one thousand”, for the words and figure “above five hundred”, the words and figure “501 to 1000” shall be substituted. After the words workers the following shall be inserted. “rupees two thousand for factories employing above 1000 workers”.
